The Client agrees to engage Debbie Lloyd Make-up Artist (the "Supplier") to perform the services, as described in this Bridal booking agreement (the "Services").

## 1. CHARGES

## 2. PRICES & PAYMENT

- 2.1. The total Cost above is fixed upon signing this Bridal Booking Agreement. The Client may request additional Services, which the Supplier shall offer a quotation against.
- 2.2. The Client agrees to pay upon signing of this Bridal Booking Agreement a non-refundable booking fee of £ 50.00 ("Booking Fee")
  - 2.2.1. The Client acknowledges that the Booking Fee is not refundable.
  - 2.2.2. The Client confirms that the Booking Fee is an accurate reflection of the Supplier's cost in relation to securing the Services.
- 2.3. The Client shall pay to the Supplier all outstanding charges (left to pay, as described above) no later than 30days prior to Wedding Day \_\_\_\_\_ 20[    ]

- 2.4. The Booking Fee is only deductible against the 'Make-up Wedding Day Cost' (as described above) and shall not be applied or off-set against any other charges due under this Bridal Booking Agreement.
- 2.5. The Bridal Booking Agreement is subject to the services being performed on two (2) persons. Failure to meet this requirement may result a surcharge, which shall not be greater than the Total Cost (described above).
- 2.6. The Make-up Trial Cost (as described above) shall be payable on or before the ate of the Make-up Trial. This shall be in cash (GBP), certified cheque or bank transfer.

2.7. The Total Cost includes travel within 20 miles of postcode SS15 5AQ, but excludes tolls, congestion charge or parking costs. Travel above 20 miles shall be charged at GBP1.00 per mile and all other costs shall be passed through at cost.

3. **TERMINATION**

3.1. The Client may terminate this Bridal Booking Agreement within 7 calendar days of signing provided that there are at least 30 calendar days left to the Wedding Day (as described above) without penalty and with the return of the Booking Fee.

3.2. The Client may terminate this Bridal Booking Agreement providing that the Wedding Day (as described above) is at least 30 calendar days after such termination and the Booking Fee shall be the only charge payable.

3.3. If the Client terminates this Bridal Booking Agreement within 30 calendar days of the Wedding Day (as described above) the Total Cost shall be payable.

3.4. The Supplier may terminate this Bridal Booking Agreement with 30 days prior notice.

3.5. The Client acknowledges that the Services are dependent on one individual, whilst every effort shall be made to find a replacement to perform the Services, the Supplier reserves the right to terminate this Bridal Booking Agreement with no notice for reasons beyond their reasonable control

4. **LIMITATION OF LIABILITY**

4.1. The Supplier's liability shall not exceed the charges paid under this Bridal Booking Agreement.

4.2. The Supplier shall have no liability for any third-party (product/service) whatsoever regardless of cause even if the Supplier recommended such third-party.

5. **DATA PROTECTION**

5.1. The Supplier shall comply within its obligations under the Data Protection Act 1998 ("DPA").

5.2. The Client shall not do any act that puts the Supplier in breach of its obligations under DPA.

6. **IMAGES**

6.1. The Supplier retains all rights whatsoever in any photograph taken by the Supplier for the sole purpose of marketing of the Supplier's Services.
